## Vendor Information and Rules

- ❖ Vendor spots will be assigned by the committee. Committee will try to accommodate special request when possible.
- ❖ "Vendor agrees to secure, at its own expense, a public liability insurance policy, with an insurance company authorized to do business in the State of Pennsylvania and acceptable to Chapter 17. Such policy shall name Central PA Chapter 17 International Harvester Collectors; International Harvester Collectors, Inc.; Bloomsburg Fair Board, 620 West Third Street, Bloomsburg, Pennsylvania as additional insured parties against all claims for injury or death to persons and injury to or destruction of property. The minimum limits of said insurance policy shall be one million dollars (\$1,000,000) combined single limit for bodily injury and property damage per person and per occurrence, the terms of such coverage to coincide with the term of this Agreement. Each policy shall provide that a 10-day written notice be given by the insurer to Central PA Chapter 17 if the insurance policy is changed or cancelled. Ten (10) days prior to commencement of the term of this Agreement, Vendor shall furnish Central PA Chapter 17 and Rainprotection Insurance a Certificate of Insurance signed, not rubber-stamped, by an agent authorized to sign for the issuing company. If said Certificate is not provided, this license is void and Vendor shall not be allowed on the grounds."
- ❖ Red Power Round Up name or logo clothes cannot be sold without the approval of Central PA Chapter 17.
- ❖ Vendors are responsible for any/all state sales tax, if applicable.
- ❖ If a vendor has special needs, they must be addressed when the vendor contract is returned. (i.e.: I am always next to or vend with someone else, I need semi entrance and exit room, I'm coming late or leaving early, I need to put up a tent on grass)
- ❖ The inside vendor area will be locked at night so you will not be able to spend the night inside the area.
- ❖ All vendors must supply their own power cords, tape to cover the cords and table coverings.
- ❖ No posting of signs or advertising outside your vending area without permission of the vendor committee.
- ❖ Vendors may enter the grounds at **9:00am on June 25** and must be out of the grounds no later than **4:00pm on June 30**
- ❖ There will be no refunds for cancelled spaces after **June 15, 2019**
- ❖ Vendors may bring their own golf cart, but will need to register it and provide proof of insurance.
- ❖ All weapons, fireworks, alcohol and pornography are banned from Red Power Round Up

## Vendor Insurance Requirement Clause for 2019 Red Power RoundUp

### **Bloomsburg Fair Grounds Fairgrounds Bloomsburg, Pennsylvania – June 27 - 29, 2019**

Vendor agrees to secure, at its own expense, a general liability insurance policy, with an insurance company authorized to do business in Pennsylvania. Such policy shall name (1) **Central Pennsylvania Chapter #17 International Harvester Collectors**, (2) **International Harvester Collectors, Inc.** and (3) **Bloomsburg Fair Board, 620 West Third Street, Bloomsburg, Pennsylvania** as additional insured parties against all claims for injury or death to persons and injury to or destruction of property and may not exclude products-completed operations hazard coverage. The minimum limits of said insurance policy shall be not less than \$1,000,000 per occurrence Bodily Injury and Property Damage combined; \$1,000,000 per occurrence Personal and Advertising Injury; \$2,000,000 aggregate Products and Completed Operations Liability; \$100,000 Fire Legal Liability, and \$2,000,000 general aggregate limit per event with the policy written on an occurrence basis and the term of such policy to coincide with the show dates. At least ten (10) days prior to commencement of the term of this Agreement, Vendor shall either furnish Rainprotection.net with a Certificate of Insurance signed by an agent authorized to sign for the issuing company or arrange to purchase the required insurance through the Rainprotection web page link on the Central Pennsylvania Chapter #17 website. If said Certificate is not provided, Vendor shall not be allowed to participate in event.

Rainprotection shall be responsible for designing a web page for use by Central Pennsylvania Chapter #17 providing a secure link for those vendors who choose the option of compliant insurance through Rainprotection.net
