- ❖ Vendor spots will be assigned by the committee. Committee will try to accommodate special request when possible.
- ❖ As a standard requirement for all of our show vendors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Vendor agrees to secure, at its own expense this public liability insurance with an insurance company to do business in Pennsylvania. This insurance must be in force during the lease dates of the event, June 26-30, 2019, naming the International Harvester Collectors Inc. (204439 Blue Ridge Parkway, Fancy Gap VA 24328) as the certificate holder. The additional insureds must read as follows: International Harvester Collectors Inc., Columbia County Agricultural, Horticultural & Mechanical Association DBA Bloomsburg Fair Board and International Harvester Collectors of Central PA, Inc. Chapter 17. International Harvester Collectors has requested that Rainprotection serve as their insurance management company. In addition to being able to provide vendors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance. If you have your own insurance, please submit a copy to **Sales@rainprotection.net**. Each policy shall provide that a 10-day written notice be given by the insurer to Central PA Chapter 17 if the insurance policy is changed or cancelled. Ten (10) days prior to commencement of the term of this Agreement, Vendor shall furnish Central PA Chapter 17 and Rainprotection Insurance a Certificate of Insurance signed, not rubber-stamped, by an agent authorized to sign for the issuing company. If said Certificate is not provided, this license is void and Vendor shall not be allowed on the grounds."

- ❖ Vendors are responsible for any/all state sales tax, if applicable.
- ❖ If a vendor has special needs, they must be addressed when the vendor contract is returned. (i.e.: I am always next to or vend with someone else, I need semi entrance and exit room, I'm coming late or leaving early, I need to put up a tent on grass)
- ❖ The inside vendor area will be locked at night, so you will not be able to spend the night inside the area.
- ❖ All vendors must supply their own power cords, tape to cover the cords and table coverings.
- ❖ No posting of signs or advertising outside your vending area without permission of the vendor committee.
- ❖ Vendors may enter the grounds at **9:00am** on **June 25** and must be out of the grounds no later than **4:00pm** on **June 30**
- ❖ There will be no refunds for cancelled spaces after **June 15, 2019**
- ❖ Vendors may bring their own golf. All personal golf carts & UTV must be registered and a fee of **\$15.00**. **No 4-Wheelers permitted. (proof of insurance required)**
- ❖ All weapons, fireworks, alcohol and pornography are banned from Red Power Round Up
